09/02/2025 (Tuesday)	If authorized by Resolution, election may be canceled if the only matter before the electors is the election of candidates and there are not more candidates than offices to be filled. <b>C.R.S. 1-5-208(1.5). 63 days before the election.</b> *At the 2025 regular City election, the election may be cancelled only if three (3) candidates run for City Council. There are four (4) Council seats to fill, but if four (4) candidates run, the election must still be conducted to determine which candidate (the lowest vote-getter) receives the partial two-year term.	
09/5/2025 (Friday)	Deadline to submit audio recording of candidate's name to Jefferson County (303) 271-8115 ( <b>60 days before the election</b> )

<p>12/4/2025 (Thursday)</p>	<p>Post-election contributions and expenditures report due for reporting period of 10/16/2025 – 11/29/2025 C.R.S. 1-45-108(2)(a)(II.5). (30 days after the election)</p>	
<p>November 2, 2026 (Monday)</p>	<p>If a candidate's last FCPA filing showed an unexpended balance or deficit, the candidate is required to file annually in off-election years on the <b>first day of the month</b> in which the anniversary of the election occurs. (One year after the election)</p>
